**AGREEMENTS:**

**FINANCIAL AGREEMENT:** The fee for the tour is \$2800 per person, double occupancy from La Paz, Mexico. This includes all meals from dinner on day 1 to farewell dinner on day 7, lodging as stated in the itinerary, ground transportation during the tour, usual and customary gratuities, and guide services provided by the tour leader.

The single supplement for this tour is \$350.00. You will be charged a single supplement if you desire single accommodations. The tour fee does not include airfare from your home to La Paz or return, airport departure taxes, alcoholic beverages, special gratuities, phone calls, laundry or items of personal nature.

**CANCELLATION POLICY:** Refunds will be made in accordance with the following schedule only if cancellation is made 60 days or more before the departure date, the deposit less \$100.00 is refundable or the entire deposit may be applied to a future tour. If cancellation is made between 60 and 30 days of departure, the deposit is not refundable but any payments above the deposit toward the balance of the fee will be refunded. There will be no refunds for any cancellation made 30 days or less before departure.

**RESPONSIBILITY:** Wild Planet Nature Tours (WPNT) and its agents provide services as described in the itinerary section of this notice from the initial destination point of the Los Arcos Hotel on Feb. 16th to the farewell at the restaurant of choice on the 23rd in La Paz. WPNT is not responsible in regard to travel to or from the beginning and ending destination points of the tour. WPNT assumes no liability for injury, damage, loss, accident, delay, or irregularity, which may occur through the acts of default of any company or person engaged in conveying the passenger to or from the tour. WPNT and its agents can accept no responsibility for losses or additional expenses due to delay, changes in air or other services, sickness, weather, strike, war, acts of God, or other causes. All such losses will have to be borne by the passenger, as rates for tour participants pertain only for the tour times as stated in the accompanying itinerary. WPNT reserves the right to change lodging location to substitutes of same quality or changes in the itinerary if necessary. WPNT reserves the right to cancel any tour prior to departure with full refunded being constituted as full settlement to the passenger. If for any reason WPNT finds it necessary to change a tour guide, notification will be given to tour members and they will have the right to cancel their participation and to receive a full refund. No refunds will be made for any portion of a tour. WPNT retains the right to decline to accept or retain any person as a member of any tour. Baggage is at owner's risk entirely.
